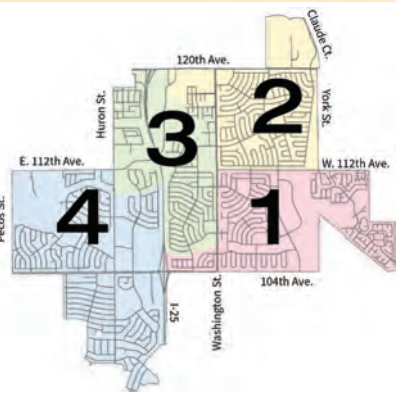

Ordinances: 2nd Reading

Municipal Code Amended for Medians

CB-1908 – Council unanimously approved on second reading an ordinance amending the Municipal Code, which adds a new section, 9-4-15, concerning pedestrian access to medians, and repeals Article 7, Chapter 7, of the code.

Re-Zoning for Church OK'd

CB-1909 – Council unanimously approved on second reading a rezoning of the property at 10700 Pecos St. from open space to residential. This will allow a church to utilize an existing 4,493-square-foot former child care center.

Addition to Budget for Northglenn Justice Center

CB-1910 – Council unanimously approved on second reading a special ordinance amending the 2018 Budget, adding \$725,000 for the costs associated with the Northglenn Justice Center project.

Ordinances: 1st Reading

Rezoning Initially Approved For Apartment Buildings

CB-1911 – Council unanimously approved on first reading the rezoning for the property at 11450 Community Center Drive, on the northeast corner of Community Center Drive and Malley Drive. The property would be converted from R-3-A Conditional to Planned Unit Development for construction of three new apartment buildings at an existing multifamily residential site containing 50 new residential units.

Resolutions:

\$340K Grant for Northwest Open Space Accepted

CR-79 – Council unanimously approved the acceptance of an Adams County Open Space Grant and the grant agreement with the Adams County Board of County Commissioners for the Northwest Open Space Renovation Project. This \$340,000 grant raises the total grant award to \$2,040,000. The amount of grant funds cannot exceed 60 percent for the total cost of the project. Romero Named to Planning Commission

CR-80 – Council unanimously approved the appointment of Nathan Romero to the Planning Commission to fill an unexpired term. His term will run June 25, 2018, to May 26, 2020.

Intergovernmental Agreement between the city and Adams 12 Five Star Schools. The school district will use city-owned undeveloped property west of the Northglenn Justice Center for installation of a new fiber optic network. This will improve connectivity between all district schools and other facilities. Construction will last from roughly July 2018 to April 2020. The city will have access to some of the installed lines.

Ordinances: 2nd Reading

Rezoning Approved For Apartment Buildings

CB-1911 – Council unanimously approved on second reading the rezoning for the property at 11450 Community Center Drive, on the northeast corner of Community Center Drive and Malley Drive. The property was converted from R-3-A Conditional to Planned Unit Development for construction of three new apartment buildings at an existing multifamily residential site containing 50 new residential units.

Ordinances: 1st Reading

Council Initially Approves Addition to CAB Functions

CB-1912 – Council unanimously approved on first reading an ordinance that would amend Chapter 2, Article 12, of the Municipal Code regarding the function of the Citizens' Affairs Board (CAB). Currently, the board only receives and considers complaints and proposals from residents concerning the city and its government. The amendment would allow City Council to authorize the board to perform additional tasks as council deems appropriate.

Resolutions

Investment Policy Updated

CR-83 – Council unanimously approved a resolution that updates the language in the city's Cash Management and Investment Policy. The policy guides and directs the investment and cash management activities associated with all public funds held by the city.

Comprehensive Financial Policy Updated

CR-84 – Council unanimously approved a resolution adopting updated language to the Comprehensive Financial Policy.

Replacement for Sidewalk and Trail Segments

CR-85 – Council unanimously approved an agreement between the city and ABCO Contracting, Inc. for the 2018 Residential Sidewalk and Trail Replacement Program. The cost will not exceed \$345,786. Work will address sections of sidewalk and trail that the city has identified as a high priority for replacement.

Private Activity Bond Funds Assigned to CHFA

CR-86 – Council unanimously approved the assignment of its Private Activity Bond (PAB) allocation to the Colorado Housing and Finance Authority (CHFA) pursuant to the Colorado Private Activity Bond Ceiling Allocation Act. In 2018 the city received an allocation of \$2,042,513. PABs are tax-exempt bonds issued by public entities that provide low-cost financing for private projects that serve a public purpose.

Street Work in Front of Northglenn Justice Center

CR-90 – Council unanimously approved change order No. 17 to the construction manager contract between the city and FCI Constructors, Inc. for roadway improvements at the Northglenn Justice Center. The amount will not exceed \$107,632.13. The pavement on Community Center Drive in front of the Justice Center has settled and is need of repair before the center opens.

Council Appoints Acting City Manager

CR-91 – Council unanimously approved a resolution appointing and setting the salary of Robert Webber as acting city manager for the city effective July 3, 2018.

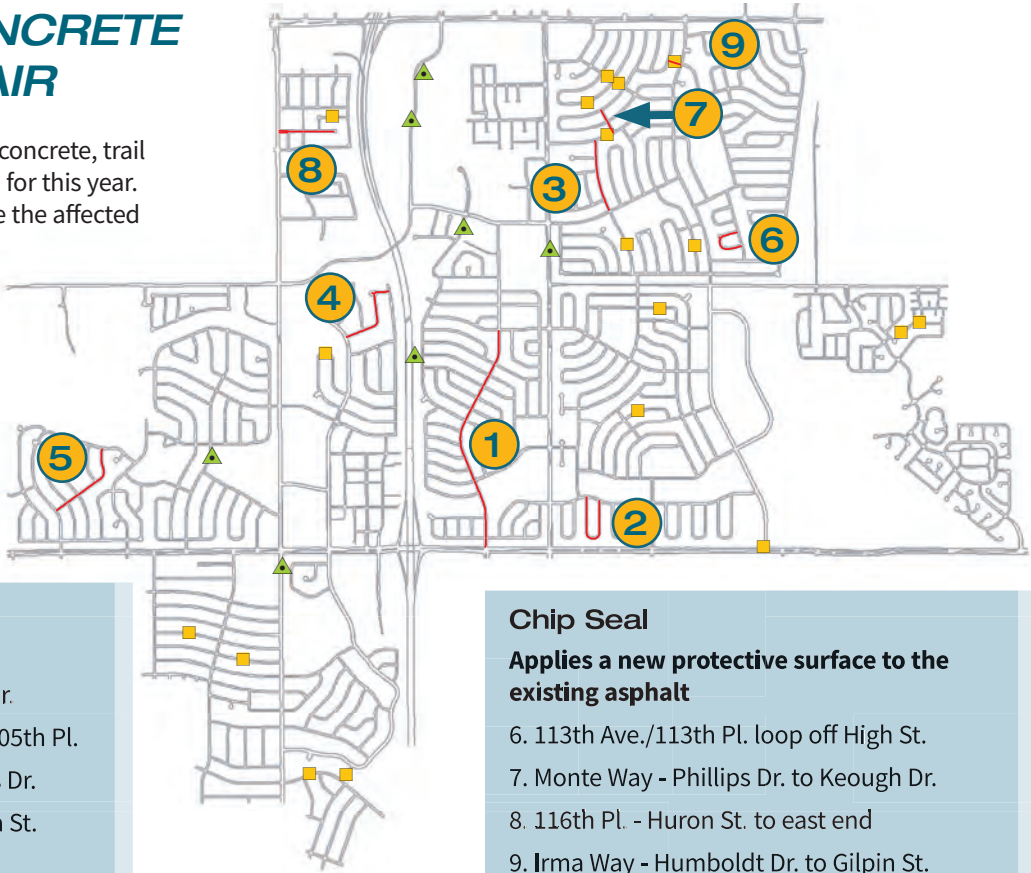

Watch Out for Illegal Dumping

Pollutants Can Flow Directly to Streams, Lakes

Protecting the city's waterways from illegal dumping is critical to keeping our environment healthy. Accidental spills and illegal dumping should be addressed as soon as possible.

Stormwater can carry pollutants from sidewalks, streets and parking lots directly into our creeks, streams and lakes. These pollutants include trash, sediment, oils, antifreeze, heavy metals, bacteria and fertilizers.

Moreover, stormwater pollution can be toxic for aquatic life, plants, animals and people.

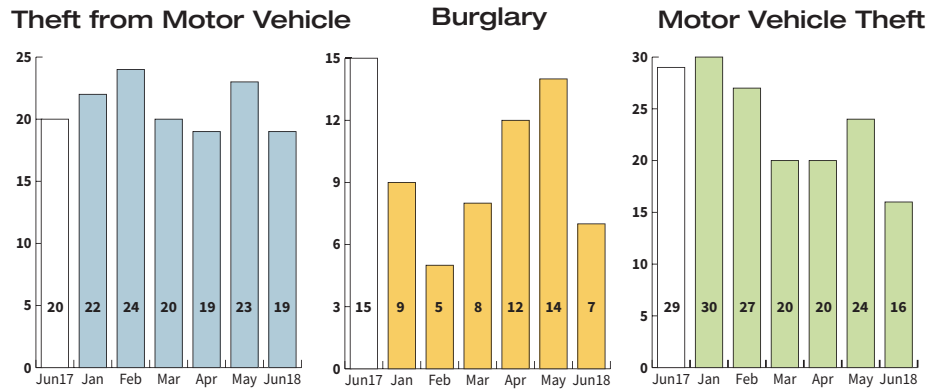

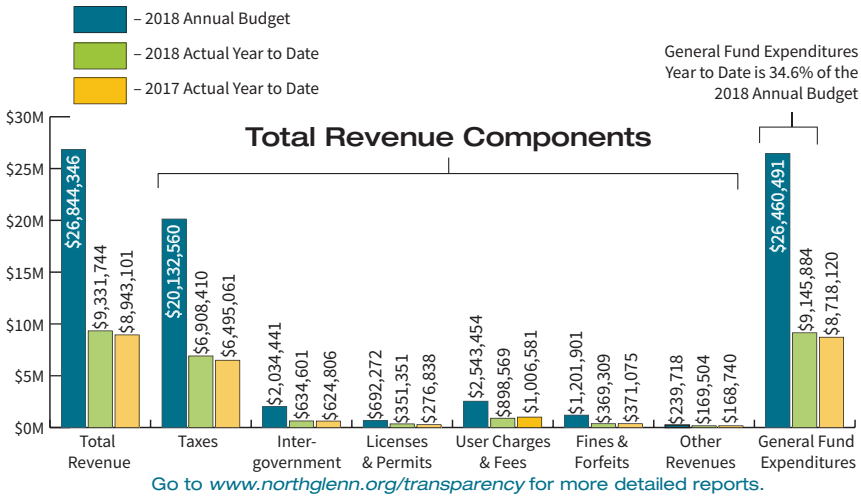
June 2018 Crime Statistics

City Council created VALE in 1990 to enhance victim assistance, crime prevention, and law enforcement programs in their efforts to assist victims and witnesses of criminal violations. As part of that purpose, the city also established a VALE Account. This

account receives its funding from a variety of citations issued by the Police Department. These funds are available to all nonprofit organizations that assist crime victims or provide crime prevention programs. Preference will be given to those organizations serving Northglenn residents.

The Sustainability Work Program's goal is to make Northglenn more livable, vibrant and environmentally-sustainable.

The project advisory group will provide input on the city's Sustainability Work Program. The program aims to address social, economic and environmental issues by setting goals and tracking citywide indicators.

The group will meet for one or two workshops in August. The first is Wed., Aug. 8, 5:30-7:30 p.m. If the advisory group determines a second workshop is necessary, we will schedule it at that time.

The city began working on this project at

the end of 2017 with consultants ICLEI – Local Governments for Sustainability, and EPS – Economic Planning Systems. The process began with an audit of existing programs in the city that work toward sustainability. The consultant team helped staff to identify gaps in sustainable activities that the city can pursue.

The consultant also facilitated City Council and staff discussions to develop a vision statement and high level goals. This advisory group will provide staff and City Council input regarding the vision statement, high level goals and strategies to make Northglenn a more sustainable community.

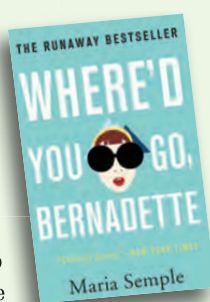
