Groundbreaking for Ralston House

► City-Located Center Aids Young Crime Victims

On March 1, after five years of planning, nine cities and two counties' hard work paid off as Ralston House broke ground on a building expansion at its Northglenn location.

Representatives from Northglenn, Adams County, Aurora, Brighton, Broomfield, Commerce City, Federal Heights, Thornton and Westminster celebrated this collaborative effort that will create more space for children and youth in our community to tell their story when an allegation of abuse is made.

"We are excited to support this unique and nearly unheard of government collaboration," said City Manager James Hayes. "As venue host to Ralston House in Northglenn, we support bringing

Take Steps to Conserve Water This Spring

► Snow Pack Well Below Normal

Voluntary water restrictions are still in effect! With spring time and warmer weather quickly approaching, it's time to think about starting sprinkler systems and outdoor watering activities. The city would like to remind residents that water restrictions set last summer are still active.

As you are starting up your sprinklers and spending more time outside, please follow

the water use guidelines listed below:

- Water no more than three days a week.
- Only water between 6 p.m. and 10 a.m.
- Use a shut off nozzle when hand watering or washing cars.
- Use a broom to clean off sidewalks and driveways.
- Avoid washing off sidewalks, patios, driveways and exterior siding.

With snow pack below average statewide,

including the Front Range, water supplies are expected to be stressed this coming summer. Help protect Northglenn's water supply by conserving water this spring.

As the summer progresses, city staff will re-evaluate the city water supply and determine if additional water restrictions will be necessary.

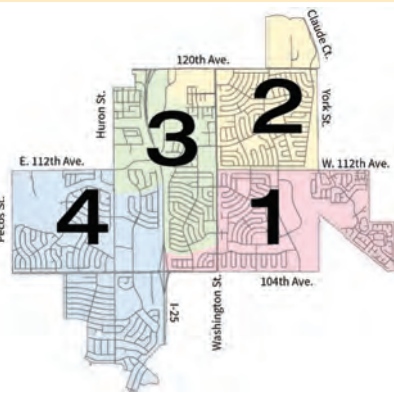

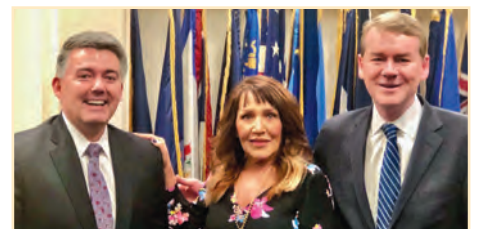

Pair Appointed to Youth Commission

Funds Set Aside for Standley Lake Pipeline

STEM Lab Reconstruction to Begin Phase II by Summer

Will Dramatically Increase Enrollment

Students, staff and families of STEM Lab in Northglenn began a two-year journey in the spring of 2017 to see their school building begin a massive, two-year reconstruction and renovation process that will not only change the environment where students learn but how they learn as well.

The 47-year-old building was once a district middle school and has been home to the STEM (Science, Technology, Engineering, Math) school since 2010.

The first phase of construction includes a 25,000-square-foot addition to the building's east side and will be completed for the start of the 2018-19 school year. In the second phase, starting in summer 2018, the building's west wing will be demolished and a new classroom wing

constructed. Classrooms will temporarily be shifted from the west wing to the new east wing over the summer. The redesigned school will feature new flexible learning spaces, a design that complements STEM-learning through features like exposed building infrastructure and a larger building footprint that will provide more STEM-learning opportunities for students across the district.

When the school's renovation is completed for the start of the 2019-20 school year, it will allow enrollment to grow from 475

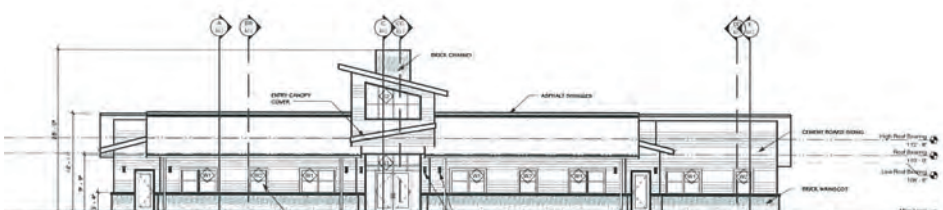

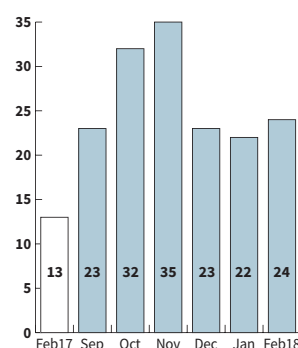

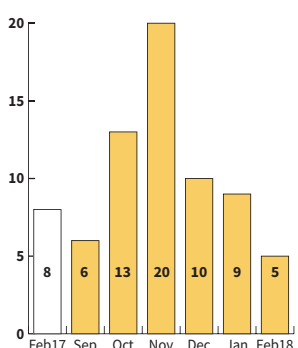

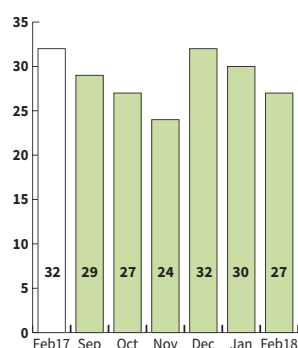
Theft from Motor Vehicle

North Metro Fire Holding Election

Questions Centered on Board Membership

Nine candidates are running this spring to fill two board of director positions for North Metro Fire Rescue District. Additionally, residents will have the opportunity to vote on a ballot question that, if approved, would extend term limits to three consecutive terms. Voters will have a chance to vote on the board candidates and ballot issue when the district's election is held on May 8.

Under current law, board members serve a four-year term and must be re-elected by voters to a second term. If the ballot passes, board members could serve up to three consecutive terms. However, they must still be re-elected by voters to each term.

North Metro Fire's board members work collaboratively with staff to set the strategic direction and vision for the fire district. Additionally, they are responsible for approving the district's budget, large contracts, guidelines and bylaws for the district, and fire codes and fees for services provided by North Metro Fire.

The board usually meets the third Tuesday of every month at 5 p.m., with a few

Even when you are doing everything right, you can't always avoid accidents and emergencies. However, you can help plan for them with help from North Metro Fire Rescue District.

Save Money on Your Ambulance Transport & Emergency Care
Any emergency where you end up at the hospital can be a costly one. Medical calls account for over 70 percent of North Metro Fire's calls annually, and the majority of those calls require medical care and ambulance transport.

North Metro Fire helps lessen the financial burden for residents through its Ambulance Membership Program (AMP). With an ambulance membership, your insurance company will be billed after you utilize their transport service, and North Metro Fire will accept your insurance company's payment as payment-in-full for up to \$1,500 annually. You won't have to pay any other out-of-pocket expenses!

The prorated price per year is \$35 for individuals and senior

- Coverage of costs associated with an ambulance transport during an emergency that are not covered by your insurance, such as co-pays and deductibles, up to \$1,500 annually for each member of your household
- Coverage for your entire household for the year (household does not include guests in your home)

New Sports Facility Coming to Northglenn



► NURA Sells Land on Washington Street to The Courts, a Privately Owned Business



The Courts Sports Complex, a new full-service, multi-sport facility, will be constructed at 11295 Washington St. Construction is planned to begin this spring, with completion by the end of the year.

"The Courts is determined to create an unmatched atmosphere that will add to the enjoyment of every user of the facility. Our vision is to be the area's leading sports venue, fueled by sports clubs and teams that inspire athletic achievement and enjoyment," said John Wray, co-owner of The Courts Sports Complex.

The 32,445-square-foot facility will house four regulation-size basketball or volleyball courts for team leagues, practices, tournaments, camps, and clinics. The facility will also accommodate pickleball, futsal, badminton, gymnastics, dance, cheer, aerobics, and more. Additionally, the space can also be rented as a venue for other events and business meetings. It will include a café, lounge and 4,270-square-foot retail area. They plan to employ around 14 people.

The Northglenn Urban Renewal Authority (NURA) sold the 2.5-acre parcel to The Courts for \$385,000.

"NURA welcomes The Courts Sports Complex to Northglenn," said NURA Chair Rosie Garner. "This project is ideal for this location and for our residents."

The Courts is a privately owned and operated facility. It estimates to attract 2,000 to 4,000 visitors per

► Reduces Chance of Reoccurring

As the weather starts to warm up, the city notices an increase in graffiti reports.

Graffiti is the most common type of vandalism in the country and nationally costs an average of \$13 billion a year to clean, according to the Department of Justice.

If you spot graffiti in the city, please call the Graffiti Hotline immediately at 303.252.3849.

Quick removal sends a message that graffiti will not be tolerated and breaks the communication chain. The longer graffiti is allowed to remain, the greater the chance of reoccurrence and the risk of other forms of crime and violence increases.

Ordinance 9-11-25.5 (b) allows owners 24 hours to remove graffiti from their property.

The city can assist residents and business owners combat graffiti through the Uniting Northglenn Together Against Graffiti (U.N.T.A.G.) program.
