
## New Rec Center Approved

### ► Facility Just West of Current City Hall Will Also House Theatre, Senior Center

The City of Northglenn is moving forward with a new recreation center, theatre and senior center.

On April 9, City Council accepted the final report and recommendations for the new facility, and approved a contract with a program management firm to move ahead with the approved plan.

The concept plan for the new facility has been developed over the past year. A community advisory committee, com-



posed of individuals with diverse interests and backgrounds, worked with staff, City Council and consultants to conduct a robust public engagement process. Input from the community was used to develop the plan.

The new facility is anticipated to cost about \$53 million. The debt service will be paid from the 2 percent marijuana tax, 1/2 percent sales tax and an annual \$1.7 million general fund transfer. The city will issue debt via Certificates of Participation (COPs); taxes will not be raised to build the new facility.

The new recreation center, senior center and theatre will replace the existing 44-year-old facility. Current designs call for the new structure to sit directly west of the current City Hall, just off of Interstate 25. The current building will remain in operation until the new facility is up and running.

The concept plan includes what features the new facility will have, and a general layout for the facility. The next step is a



## MARCH 26, 2018

### Ordinances: 2nd Reading

#### Approval for Creation of Utilities for Water, Sewer

CB-1904 – Council unanimously approved on second reading a bill that revises Article 20 of Chapter 16 of the Municipal Code to create a separate water utility and sewer utility, both of which are accounted for in the city's Water and Sewer Utility Fund.

### Resolutions

#### Walters Reappointed to Planning Commission

CR-48 – Council unanimously approved the reappointment of Carolann Walters to the Planning Commission for a term starting March 26, 2018, and expiring March 26, 2021.

#### New Pedestrian Bridge for Croke Reservoir

CR-49 – Council unanimously approved a trade contractor agreement with L&M Enterprises, Inc. for an amount not to exceed \$35,095.64 for the Croke Reservoir Pedestrian Bridge Abutment Construction and Bridge Installation Project. The existing pedestrian bridge at Croke Reservoir is settling and needs to be replaced. The old bridge is being removed and replaced in the same location with a new structure.

#### Repairs for Northglenn Marketplace Bridge

CR-50 – Council unanimously approved a trade contractor agreement with ABCO Contracting, Inc. for an amount not to exceed \$314,875 for the Marketplace Bridge Rehabilitation Project. Needed repairs will be made to the bridge, which goes from just west of 107th Avenue and Lincoln Street over Interstate 25 to the northeast edge of the Northglenn Marketplace.

#### Upgrades for Evidence Lockers at Justice Center

CR-53 – Council unanimously approved Change Order No. 11 to the construction manager contract between the city and FCI Constructors, Inc. to include evidence pass-through locker upgrades in the Northglenn Justice Center. Electronic card readers will be installed that will more accurately and securely record all transactions through the lockers. The amount of the upgrades will not exceed \$61,463.

CR-51 – Council unanimously approved waiving liquor license fees for the Northglenn Arts & Humanities Foundation, Northglenn Community Foundation and Historic Preservation Foundation for various city-sponsored events.

## GRANTS FOR NONPROFITS

The city is accepting applications for the 2018 Outside Agency Funding (OAF) Grant Program.

The 2018 Budget includes \$15,000 to be awarded to nonprofit organizations that directly serve Northglenn residents.

The City Council OAF Committee will review the applications and make recommendations to the full council on funding amounts.

### Biosolids Contract Approved

CR-52 – Council unanimously approved an agreement with Veris Environmental, LLC, for an amount not to exceed \$300,000 to provide biosolids loading, hauling and disposal services at the Wastewater Treatment Plant in 2018.

### Land Near Justice Center Purchased for Park

CR-54 – Council unanimously approved the purchase of property located at Cherokee Street and West 112th Avenue for an amount of \$62,238 from the City of Westminster. This property is located just west of the Northglenn Justice Center construction site and will be used as a park and open space. **See brief on page 4.**

### Design Services for Park Near Northglenn Justice Center

CR-55 – Council unanimously approved a professional services agreement with DHM Design Corporation for the Justice Center West Park Phase 1 Master Plan Project for an amount not to exceed \$33,450.

The district celebrates Blunt and her dedicated staff for receiving this prestigious honor from the Colorado Association of School Executives (CASE), in conjunction with the Colorado Association of Secondary School Principals.

When Blunt first arrived at Northglenn,

she decided the best way to turn things around was to face the student achievement data head on. She encouraged her staff to take time to reflect on what they did in the past, take note of what worked and what didn't, identify root causes, and then work collaboratively to create a plan for moving forward.

Under Blunt's leadership, Northglenn has achieved significant academic success, reaching a graduation rate of 89.8 percent for the Class of 2017, up more than 20 percentage points from 2010.

“Getting really good people to pursue

recognition for their work is hard,” said Lee Peters, executive director of secondary schools for Adams 12. “Sharee is very humble in her work, and I know for her, this is very much a Northglenn High School award, not a Sharee Blunt award, and because of that I am honored to be able to recognize her.”

As Colorado High School Principal of the Year, Blunt will compete for National Principal of the Year recognition, which will be announced later this year. She will represent Colorado and be honored along with other state winners in Washington, D.C. in early fall 2018.




March 2018 Crime Statistics



## A-Lift Provides Transportation to County Seniors, Disabled

Transportation can be a major issue for seniors and the disabled, especially when it involves going to the doctor or grocery store. Thankfully, A-Lift is available for Adams County residents with these challenges.

An A-Lift shuttle will pick up people over 60 years old or who are disabled to give them a ride for free. (A \$5 donation is suggested.)

Acceptable destinations include:

- Medical appointments
- Dental appointments

- Adult day and respite programs
- Grocery stores
- Congregate meal sites
- Personal trips within five miles of the home

Rides are generally available weekdays from 6 a.m. to 6 p.m. on a first-come, first-served basis.



