# **Center Entering** Design Phase

### Building Set to Start West of City Hall in Late 2019

Design for the new recreation center, performing arts theatre, senior center and Memorial Parkway is in full swing. Project Architect Barker Rinker Seacat (BRS) and their design team partners are underway with the schematic design process. Based on the current design schedule, construction is expected to start in the fourth quarter of 2019.

Schematic design takes the approved conceptual design and starts to define the project requirements and goals. The completion of the schematic design phase results in a drawing package that can include site plans, preliminary floor plans, building elevations and initial descriptions of the building systems.


All of the proposed uses that residents indicated were of the most interest fit nicely into the design, including a 300-seat performing arts theatre, a lap/competition pool, a warmer water leisure pool, a preschool area, a main level senior center with a catering kitchen, fitness rooms and more. We may have even found a way to include a whirlpool space with heated jets, as we know a hot tub was one of the common requests that we were not able to fit into the budget during the conceptual plan-

ning phase. More details to come soon!

The city is in the process of selecting a Construction Manager/General Contractor (CM/GC). Bringing a CM/GC on board during the design process helps to ensure the design evolves within the approved construction budget. Construction is planned



to begin in late 2019, with the recreation center, performing arts theatre and senior center expected to open in 2021. The new facility will be located directly west of the current City Hall.

In the coming months, we will ask you to help us select the indoor play structure and the pool play features. We will also post updated drawings of the facility as they are developed. 

#### JAN. 28, 2019

**Ordinances: 1st Reading** 

#### **Initial Approval to Update** Ordinance Language

CB-1919 - Council unanimously approved on first reading an ordinance that would update language concerning parking, nuisances and animals in chapters 7, 9 and 14 of the Municipal Code. This would bring these articles in line with the Unified Development Ordinance and also clarify and specify language.

#### Initial Approval for Zoning Code Overhaul

CB-1920 - Council unanimously approved on first reading an ordinance that would adopt the Unified Development Ordinance (UDO) as the new Chapter 11 of the Municipal Code. It would also adopt an updated zoning map for the city. The UDO is an update and consolidation of 40+ years of zoning code and subdivision regulations. The current chapters 11, 12 and 21 of the Municipal Code would be repealed. For more information on the UDO, go to www.northglenn.org/newcode.

#### **Resolutions:**

#### Grant to Provide Legal Counsel at Court

CR-7 - Council unanimously accepted a grant of \$5,220 from the Defense Counsel First Appearance Grant Program of the Colorado Department of Local Affairs. The funds will be used to provide legal counsel to defendants at their first appearance in Northglenn Municipal Court. The number of defendants in custody in August 2018 determined the grant amount.

#### Cities to Continue Sharing Victim Services Unit

CR-9 - Council unanimously approved Intergovernmental Agreement between Northglenn and Thornton to share victim services in 2019. The two cities have shared these services since 1987. The Victim Services Unit provides critical and timely support to victims and witnesses of crime in the two cities. Northglenn will cover \$114,931 of the unit's \$572,587 total budget.

#### **Unified Development** Ordinance and Map Adopted

CB-1920 - Council unanimously adopted this ordinance on second reading. See the Jan. 28 recap for more information.

**Ordinances: 1st Reading** 

#### Pawnbroker Business Rules Changes Initially Approved

CB-1921 - Council unanimously approved on first reading an ordinance that would modify pawnbroker regulations in Chapter 18, Article 3 of the Municipal Code. Pawnbroker businesses would be allowed to operate on Sundays and all holidays. Also, it would revise language regarding the fee a pawnbroker can charge a person to retrieve a pawned item. It would not exceed one-fifth of the original purchase price for each month, plus the original purchase price. This would bring the city in line with state

#### Renberg Reappointed to Youth Commission

CR-11 - Council unanimously approved the reappointment of Everett Renberg to the Northglenn Youth Commission. His term runs Jan. 22, 2019 to Jan. 22, 2020. The Northglenn Youth Commission encourages youth to participate in community issues and gives them a voice in government. Members make recommendations to City Council and staff about topics that impact youth in the community.

#### **Unified Development** Ordinance Manual Adopted

CR-12 - Council unanimously approved the adoption of the Unified Development Ordinance (UDO) Administrative Manual. This document contains details about the development review process, information for potential applicants and development review forms. The UDO

Schools in Northglenn are displaying various pathways to student success.

#### Northglenn High School

According to the Colorado Department of Education, during the 2017-18 school year, Northglenn High had the lowest dropout rate in their history at 1.1 percent. Northglenn's rate is an improvement of more than 5 percentage points from 2010, meaning more than 120 students are remaining in school compared to eight years ago. In addition, their graduation rate of 89.4 percent is nearly nine percentage points higher than the state average.

#### Vantage Point High School

Vantage Point High School increased the number of graduating students by 6.3 percentage points in 2018, representing an increase of 37.1 percentage points since 2010. Vantage Point offers an individualized program for students in grades 9 to





#### **Community Loss**

Northglenn lost an outstanding community member with the passing of Jessie "Sonny" Holt. He was dedicated to the Police Department as a volunteer member of the Citizen's Police Academy Alumni Association of Northglenn (CPAAAN). The police even named him volunteer of the year in 2014! His friendly smile and presence will be missed by all who knew him.

#### Justice Center Under Budget

The Justice Center came in under budget! After everything was calculated – including design, street improvements, construction, etc. – the final cost was

\$23.6 million. That's about \$600,000 under what was approved by council. Great job!

#### Unified Development Ordinance Approved

Council also approved the Unified Development Ordinance (UDO). Over the past 40 years, sections have been added to the city's zoning ordinance. This left zoning regulations in different sections of the city's Municipal Code, and some of them were not in line with current standards. So, our Planning Division worked with consultants to update the zoning regulations when necessary and then put them all together into the UDO. This will make things easier for builders, developers and everyone else who has to work with the zoning code. Thank you to the UDO task force members who assisted with this effort!

#### Traffic Calming Measures

We've heard your concerns, and the city is taking measures to reduce speeding issues and provide safer crossings. The temporary speed humps installed at Claude Court, Livingston Drive, Melody Drive and 112th Place have been effective in reducing speeds on these streets.

#### E. 112th Avenue Road Work

Work has begun on improvements on East 112th Avenue. The sidewalk will be extended at the future commuter train crossing at the intersection of 112th Avenue and York Street, and a traffic signal will be installed at Fox Run Parkway and 112th Avenue. This project is expected to be completed in the spring.

### **Ground Breaks** on New Multi-Sport **Facility The Courts**

The city broke ground Feb. 5 on The Courts Sports Complex, a full-service, multi-sport facility to be constructed at 11290 Washington St. It is scheduled to open in September 2019.

"The Courts is determined to create an unmatched atmosphere that will add to the enjoyment of every user of the facility," said John Wray, co-owner of The Courts Sports Complex. "Our vision is to be the area's leading sports venue, fueled by sports clubs and teams that inspire athletic achievement and enjoyment."

The 31,500-square-foot facility will house four regulation-size basketball/volleyball courts that will highlight the main floor for team leagues, practices, tournaments, camps, and clinics. Additional courts at the facility will accommodate pickleball, futsal, badminton, gymnastics, dance, cheer, aerobics and more. The space can also be rented as a venue for other events and business meetings.

"This is the perfect site for a much needed sports

facility, not only for our community, but also throughout the metro north region," said Mayor Carol Dodge. "The Courts will provide an opportunity for all ages to play sports in a state-of-the-art facility. It will also provide a safe place and atmosphere for kids to have a positive athletic experience, while having fun."

The facility is estimated to draw between 2,000 and 4,000 visitors per week. It will include a café, lounge area and retail component. Approximately 20 percent of its users will be adults, with the remaining being youth ranging from 5 to 17 years of age. The facility plans to employ around 14 people.


"The City of Northglenn has worked well with us to achieve our goal. I'm confident the public will embrace our programs," said Dean Teuber, co-owner of The Courts.




