Water Restrictions in Effect

► Be Water Wise, Help Conserve

Northglenn is joining Denver and Aurora, the other cities in the metro area who have implemented water restrictions.

Water is a scarce and precious resource here in Colorado. The lack of precipitation that we’ve experienced from July 2015 through April 2017 had a lasting, residual effect impacting the water supply of the city. During July and August the water available to the city from run off in the mountains will decrease, while demand increases.

Conserve! Help us get through the summer by reducing water consumption in your home. That reduction will help to assure

WASTE OF WATER GUIDELINES

- Outdoor watering is limited to the hours between 6 p.m. and 10 a.m.
- Water your lawn three days a week
- No excessive water in the gutters
- No watering on a windy or rainy day

- Outdoor water use is limited to watering lawns and gardens.
- Washing cars, sidewalks, siding, or outdoor features with a hose is prohibited. Use a bucket instead.

everyone has the amount of water they need. The city is asking for your help in the months ahead.

**Waste of Water Ordinance, Enforcement**

The city will be enforcing the Waste of Water ordinance that helps to assure water conservation requirements will be met. Violators may be subject to fines.

CONSERVATION TIPS

Here are tips that can help save water:

- Run the dishwasher only when it’s full and use the “light-wash” option
- Run full loads of laundry
- When cooking, peel and clean vegetables in a large bowl of water instead of under running water
- Take short showers instead of baths
- Repair leaks around the house

► Have a free inspection of your lawn sprinkler system. To schedule, go to [www.conservationcenter.org](http://www.conservationcenter.org).

- Turn off the water to brush your teeth and shave

- Install a toilet dam, faucet aerators, and low-flow showerheads
- Take advantage of rebates offered for the purchase of a water saving washing machine or low-flow toilet
- Set your lawn mower blades to cut the grass 2-3 inches high
- Use a broom, not a hose, to clean driveways, patios and sidewalks

Possible New Rec Center for City

► Assessment for Facility, Programming and Staffing

Following the April 2017 approval of Northglenn’s Civic Center Master Plan, the City of Northglenn has begun the Facility, Programming & Staffing Assessment to explore the possibility of a new recreation center, senior center and theater.

Public outreach during the Civic Center Master Plan process showed strong support for these new facilities and a desire for a new “downtown.”

**Assessment**

This assessment begins phase one of implementing the Civic Center Master Plan. It will include an in-depth analysis of facilities, programming and staffing of the current and future recreation amenities in anticipation of a new multi-use

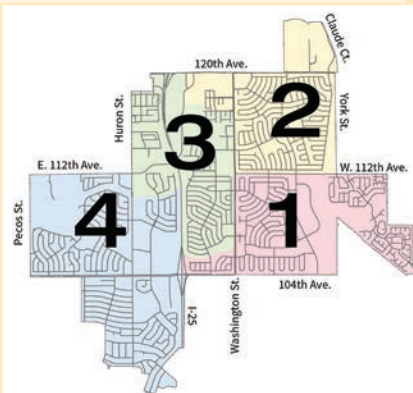

## JUNE 26, 2017

### Ordinances – 1st Reading:

#### Initial OK for New Starbucks

CB-1890 – In a unanimous vote on first reading, council approved a request from the Planning Commission recommending approval of the Planned Unit Development for the Starbucks at 104th Avenue and Melody Drive.

#### Initial Approval for Residents With License to Sell Home Raised Eggs or Honey

CB-1891 – Council unanimously approved on first reading an amendment to Section 11-5-2 of the Municipal Code allowing residents who are licensed to own chickens or bees to sell the eggs or honey.

### Resolutions:

#### VALE Grant for Police Narcotics Scanner Approved

CR-67 – In a unanimous vote, council approved acceptance of a grant from the Northglenn Municipal Victim Assistance and Law Enforcement (VALE) Board in the amount of \$11,025 for the grant application submitted by the Police Department for the purchase of one TruNarc laser narcotics scanner.

#### Easement for Private Sewer Line Approved

CR-68 – Council unanimously approved a correction easement between the city and 2255 E. 104th Ave. for the construction, maintenance, repair, removal, and replacement of a private sanitary sewer line.

#### Rights of Way Agreement for Small Wireless Facilities

CR-69 – In a unanimous vote, council approved the Master License Agreement for the use of public rights of way with Mobilitie, LLC, for “small cell wireless facilities.”

#### Approval of Analysis for Possible New Rec Center

CR-70 – In a 6-3 vote, council approved the contract in the amount of \$116,071 with Barker Rinker Seacat Architecture for the completion of public engagement, conceptual design, staffing assessment, preliminary construction estimates and ongoing costs for a new recreation center.

Mayor Pro Tem Carol Dodge, Ward 1 City Council member, was elected president of the Colorado Municipal League (CML) executive board for 2017-18 at the 95th Annual CML Conference held June 20-23 in Breckenridge.

This is Dodge’s third senior board position, having served as vice president for 2016-17 and as board secretary/treasurer during 2015-16. The executive board is comprised of 21 elected and appointed individuals from municipalities.

Dodge was elected to her first term on City Council in 2009 and ran unopposed in 2013 for her current second term. Presently, Carol serves as council liaison to the Northglenn Youth Commission, the Northglenn Senior Organization and the Northglenn Arts & Humanities Foundation. She has been on the CML Policy Committee since 2009.

## JULY 10, 2017

### Ordinances – 1st Reading:

#### Initial OK to Prohibit Cell Phone Use While Driving

CB-1892 – Council unanimously approved on first reading to add traffic offenses in keeping with 2017 state legislation prohibiting using a cell phone while driving and texting while driving.

### Ordinances – 2nd Reading:

#### New Starbucks Development on 104th Avenue Approved

CB-1890 – In a unanimous vote, council approved on second reading a recommendation by the Planning Commission for approval of the Starbucks at 104th Avenue and Melody Drive in regard to preliminary and final planned unit development.

#### Licensed Residents Can Sell Eggs or Honey From Home Raised Chickens and Bees

CB-1891 – Council unanimously approved on second reading an amendment to the Municipal Code to allow the sale of eggs and honey from those residents who have licenses to keep chickens and bees. A Home Occupation license is also required

as is proof the resident has completed the required food safety class.

### Resolutions:

#### Council Accepts Law Enforcement Grants

CR-72 – In a unanimous vote, council approved acceptance of the following grants:

- \$4,766 in grant funding from the Peace Officer Standards and Training (P.O.S.T.) for training equipment
- \$10,000 in grant funding from the Colorado Department of Transportation Law Enforcement Assistance Fund (LEAF) for personnel services, overtime and equipment for DUI enforcement
- \$12,000 in grant funding from the Colorado Department of Transportation High Visibility Impaired Driving Enforcement (HVE) Program for personnel services overtime for holiday DUI enforcement.

#### Citywide Fence Maintenance Project Agreement Amended

CR-73 – Council unanimously approved Addendum No. 1 to the Trade Contractor Agreement with Integrated Site Services, Inc., in an amount not to exceed \$12,000, for the Citywide Fence Maintenance Project.

# NHS Parking Permit Area Grows

We love our high school students, but... sometimes parking in the residential neighborhoods around Northglenn High School (NHS) can be a problem.

To help remedy that, the city added more designated areas to the NHS Parking Permit Program as part of the city’s School Zone Improvements Program. This will re-establish existing restricted parking areas surrounding NHS to more effectively discourage students from parking there.

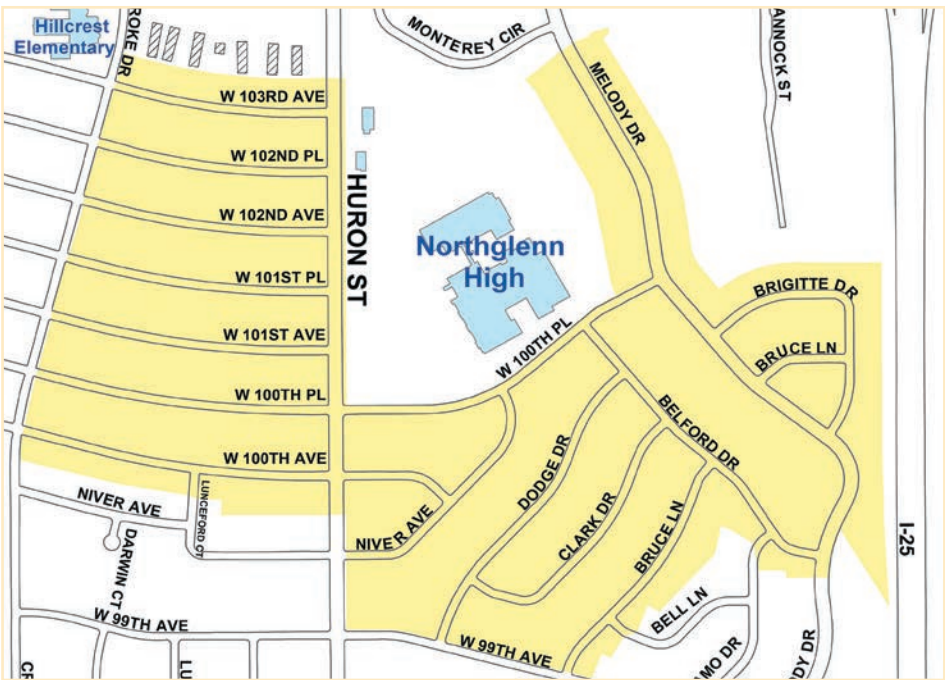
To make the designated areas easy to identify, new signs are being installed.

Parking permit letters and applications were mailed to residents living in the designated areas for parking/visitor permits.

Vehicles parked on the street during school hours, 7 a.m.-3:30 p.m., will need a parking permit. Effective dates for the permits are Aug. 1, 2017 – June 30, 2018.

Permits are free and each vehicle can have their own; visitor permits are one per address.

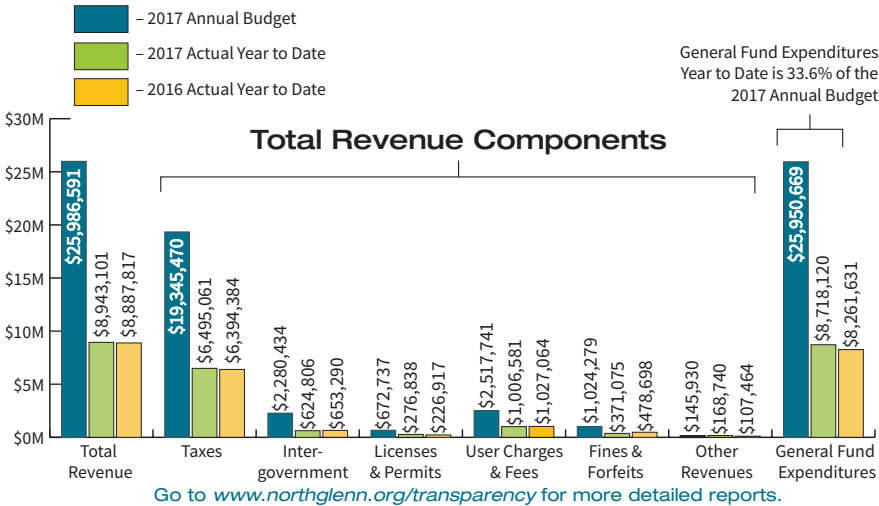

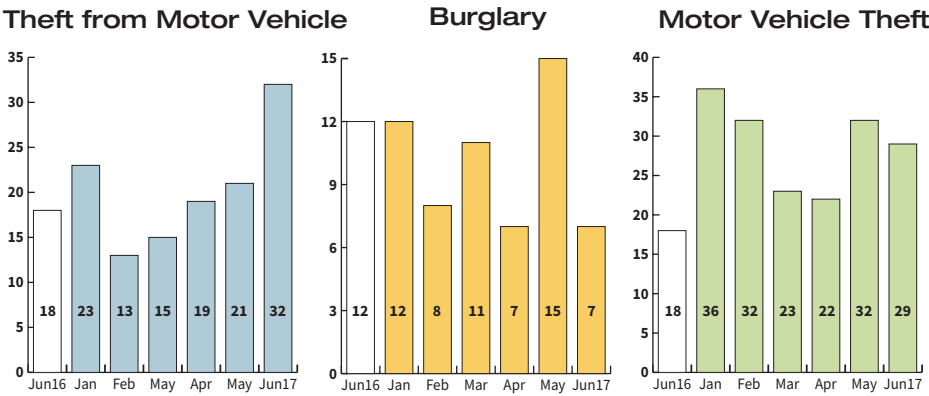

facility on the civic center campus. The size and features of the proposed multi-use facility will ultimately be determined based on public input and project budget.

A key step will be understanding the program needs and desires of our changing community. Ultimately, the recommended facility and programs will be assessed to determine a sustainable approach for staffing, maintenance and operations.

Public Input

The public input process will occur between September 2017 and February 2018. The assessment project has an anticipated completion date of March 2018.

Opportunities to provide input and feedback will include focus groups, an online questionnaire and open houses.

Specific meeting dates will be announced mid-August and in the September Connection.

Project Advisory Group

A small advisory group is being formed to provide ongoing input for this project. The purpose of the committee will be to take information collected from City Council, public meetings and the consultants. They will work together as a team to study the input and alternatives, and make recommendations to help guide how we proceed with the project.

The committee will meet for a series of five four-hour workshops on Wednesday evenings between September and January.

New Bike Lane Project

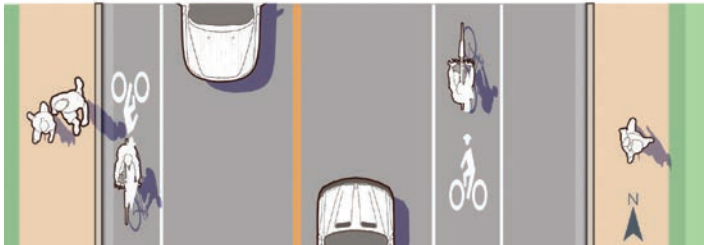
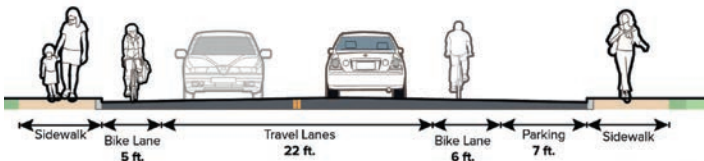
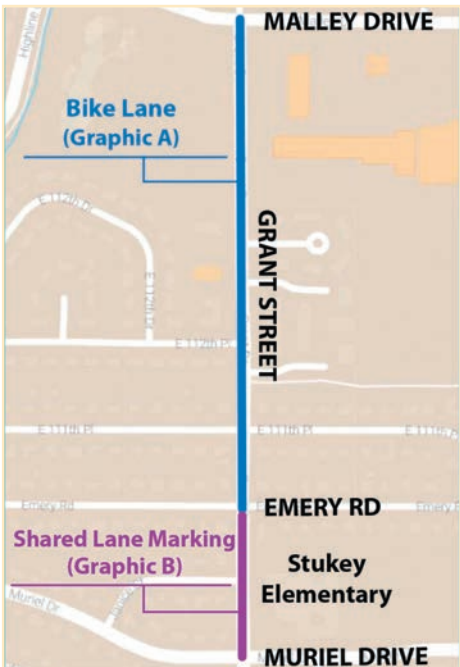
Cyclists and motorists are encouraged to try out the new configuration and provide their opinions. The city will have a public

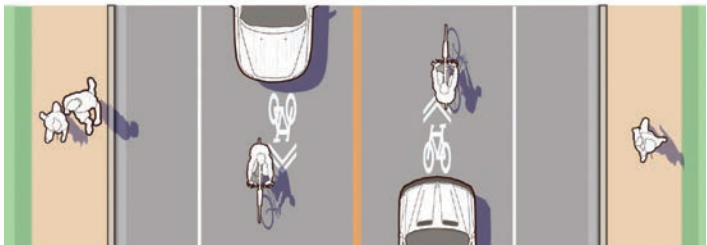
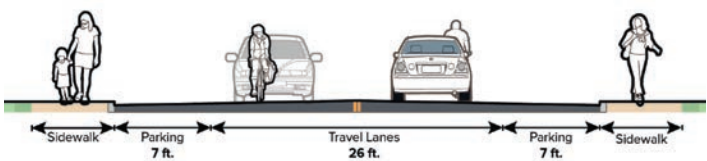
This section of street was chosen because:

## ► AutoZone Mega Hub Moving into Former Albertsons

On July 7, Evergreen Development closed on the former Albertsons/Rite Aid property owned by the Northglenn Urban Renewal Authority.

The total project is estimated at \$9.7 million, and includes acquisition costs and improvements to all the existing buildings, landscaping, parking lot, stormwater infrastructure and much more.

Construction begins soon. Most of the work on the existing buildings and property is scheduled to be done by early 2018.

Arby's is planning to open in late spring 2018. Watch for more details on a formal groundbreaking ceremony and construction updates.

AutoZone will be leasing 35,268 square feet at 1002 W. 104th Ave. in the Huron Center for their new Mega Hub facility. They plan to open in early 2018.

AutoZone is the leading retailer and distributor of automotive replacement parts and accessories in the country.

The Northglenn Mega Hub will have a 6,000-square-foot retail store in the front and a fulfillment center in the back that will house approximately 100,000 parts.

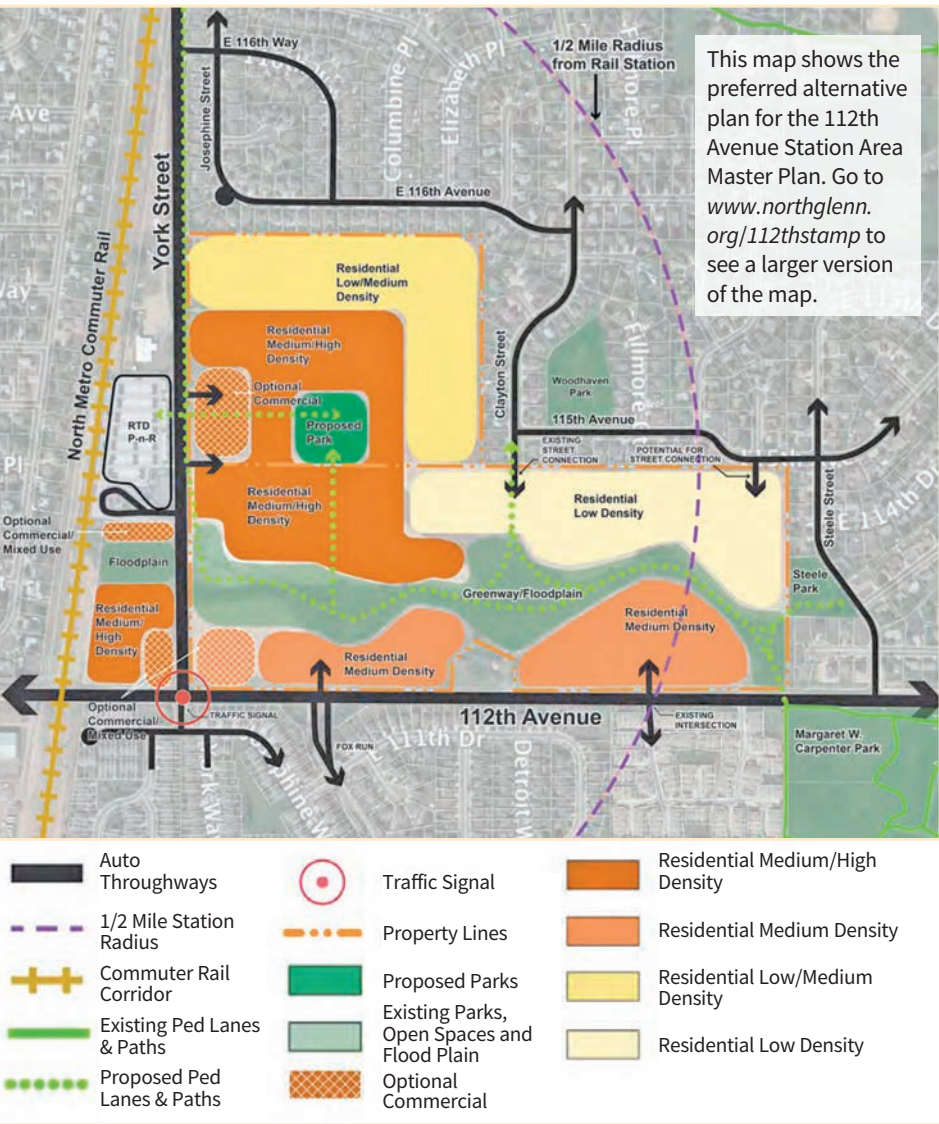

# Layout Chosen for 112th Avenue Station Area Master Plan

## ► Will Guide Development Around FasTracks Commuter Rail Station

The cities of Northglenn and Thornton have agreed upon a preferred alternative plan for the 112th Avenue Station Area Master Plan (STAMP).

STAMP is a vision of future land use and transportation infrastructure near the Northglenn at 112th Station. STAMP touches on roughly a square mile radius of the future RTD FasTracks commuter rail station, which will be located just north of 112th Avenue near York Street, right on the Northglenn/Thornton border.

During the planning process, the public provided input on the plan online and at meetings.

STAMP was developed with the follow-

ing guidelines and goals in mind for future development:

- Have a vibrant, walkable, mixed-use community
- Compliment the rail station and commuter train service
- Maximize the property's development potential
- Ensure a sense of place
- Diversify housing
- Increase retail opportunities

Both cities will look for opportunities to incorporate elements of the plan in future projects. When private developers bring proposals to develop the land around the 112th Station, the cities will work with those developers to achieve the goals listed above.

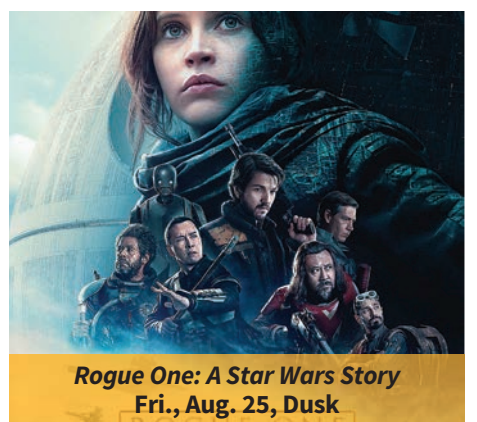
