
BEE *AWARE*



Preliminary Approval for Rezoning

CB-1879 – Council unanimously approved on first reading an amendment to the Northglenn Pavilions Planned Unit Development (PUD) for a multi-family development of 34 units to be located at 12155 Claude Court.

Resolutions Contractor for Project

CR-6 – Council unanimously approved an agreement with Richdell Construction, Inc. for the Fox Run Open Space Improvement Project. The amount is not to exceed \$143,000.

City, Thornton to Still Share Victim Services

CR-7 – In a unanimous decision, council approved an agreement with the City of Thornton to continue its shared victim services program. The program is funded through the sharing of expenses by Thornton, Northglenn, the 17th Judicial Victim Assistance Law Enforcement (V.A.L.E.) funds and Victims of Crime Acts (V.O.C.A.) funds.

Cities to Jointly Maintain Streets

CR-8 – Council unanimously approved an agreement with the City of Westminster for maintenance of Huron Street from West 112th Avenue to 120th Avenue, as well as West 112th Avenue from Alcott Street to Huron Street.

Council Funding Committee Set

CR-9 – In a unanimous decision, council approved the appointment of council members Kyle Mullica, Becky Brown and Kim Snetzinger to the Outside Agency Funding Committee beginning Jan. 23, 2017, and expiring following certification of election results of the November 2017 regular election.

Reappointment to Historic Commission

CR-10-In a unanimous vote, City Council approved the reappointment of Elizabeth

Candelario as a member to the Historic Preservation Commission for a three-year term commencing Jan. 24, 2017, and expiring Jan. 24, 2020.

Trio Reappointed to Youth Commission

CR-12, CR-13, CR-14 — Council unanimously approved the reappointments of Alexandra Donnici, Savannah Van Duyn and Peyton Larsen as members of the Northglenn Youth Commission for a one-year term. The terms of Donnici and Van Duyn expire Nov. 25, 2017, and Larsen's term expires Dec. 16, 2017.

Focus on Healthier Food at City Concessions

New Choices Available Soon at Rec Center

The City of Northglenn will be phasing in healthier snacks and beverages in city-owned and operated vending machines and concession stands over the next three

As part of the city's commitment to improving access to healthy food in the community, it worked with Tri-County Health Department to assess current vending and concession offerings in city parks and facilities.

The city's Healthy Eating Active Living (HEAL) and SmartLiving committees then teamed up to find healthier alternatives. A taste test and survey conducted in December found community members overwhelmingly supporting the new healthier options.

The healthy food roll-out will start soon in the Northglenn Recreation Center. The goal is to have all the city-operated vending machines and food stands offering only healthy food by 2020.

Please note that this policy does NOT apply to any private businesses with vending machines or concession stands.





Neighborhood Services Seeks to Aid Residents

Code Warning Notice Not A Citation or Fine

You spot a paper notice on your front door. It's a warning notice for a code violation from the city's Neighborhood Services Division. You've never received one before and aren't sure how to react. First – don't panic.

This is just a warning notice – not a citation or a summons and complaint, and certainly not a fine. The warning notice simply states what violation the Neighborhood Service Officer saw and how long you have to correct the problem.

Most of the 140 or so violation notices that Neighborhood Services gives out every month are for things like litter, signs on the side of the road and broken down vehicles. Almost 90 percent of the violations are quickly dealt with by residents, and the city would like to thank you for that!

If you receive a notice and can't fix the problem in the allotted amount of time, please contact Neighborhood Services immediately at 303-280-7876. That way, we can work together to find a solution that works for you, the city and the neighborhood.

ELIGIBILITY

To be eligible for the lock box program, participants must:

- Be a resident of Northglenn
- Live in a private home or apartment
- Have significant medical assistance needs or be a senior who lives alone
- Provide a spare house key
- Sign a release and agree to return the lock box if no longer participating in the program

The Key to Fast Help

Lock Box Gives First Responders Access When Doors Locked

Emergency personnel may lose critical minutes when a house is locked preventing first responders from getting inside.

There is a solution – the Police Department provides lock boxes, similar to those used by real estate agents, to hold a spare house key. When emergency personnel are called to that home, dispatch can provide the combination if there's no answer at the door.

The lock box hangs in a secure location at the residence, and there is no cost to the resident.




