Redevelopment for Huron Center

► \$7.36 Million Construction Project to Start This Summer

On April 3, the Northglenn Urban Renewal Authority (NURA) approved agreements with Evergreen-104th & Huron, LLC, and Impala Capital, LLC, to redevelop the 10.45-acre, 104,322-square-foot Huron Center.

"This project is a great example of what urban renewal authorities can do to revitalize challenging retail areas by bringing stakeholders to the table," said Rosie Garner, chair of NURA. "Thanks to a very dedicated developer and patience from our residents, the Huron Center will be transformed."

New businesses that will move into the shopping area, located at 104th Avenue and Huron Street, include:

- A 35,669-square-foot automotive parts retail facility
- A 21,773-square-foot neighborhood grocer
- A newly-constructed, 2,400-square-foot Arby's restaurant

The total project with acquisition costs is estimated at \$9.4 million, which includes \$7.36 million for construction.

Project construction will start this summer. The grocer and retail automotive parts facility are scheduled to open by the end of 2017 or early 2018. The newly-constructed Arby's restaurant is set to open in

the fall of 2018.

"This is a great day for the city," said Mayor Joyce Downing. "This project will jump start the Huron Center. These new businesses are investing in the city while bringing in products and services of value to our residents."

Under the agreements, Evergreen will

purchase the former Albertsons/Rite-Aid building and property at 1000 W. 104th Ave. from NURA. The grocer and retail automotive parts facility will be located there. They will also own the new Arby's restaurant that will be constructed next to Bank of the West.

Impala will continue to own the rest of the center, which includes the east and west wings, and the two existing restaurant buildings near 104th Avenue.

"This has been a complex project from the beginning, but it will be worth everyone's efforts when we see how this project will transform this property and revitalize the area," said Debbie Tuttle, who is the executive director for NURA and economic development manager for the city.

City Seeks Reduction in Water Use

You may be aware that the eastern slope of Colorado is experiencing drought conditions. In fact, almost 90 percent of the state is now considered to be abnormally dry or in drought conditions.

The snow in the mountains doesn't mean that Northglenn's water supply is safe from summer demands. In Northglenn, we've experienced drought conditions before, and together, we conserved and everyone did their part to save water. Considering

the drought conditions we are facing, the city is asking residents to once again practice water conservation.

In order to protect our water supply, ensuring that there is enough water for all residents this summer and into the winter, the city will continue to enforce its Waste of Water Ordinance.

The ordinance is not considered "mandatory" restrictions, but does provide guidance for residents about using water in a

responsible manner. Currently, no fees will be assessed for violators, but they may receive a notice of violation. Provisions in the Waste of Water Ordinance that will be enforced starting in May 2017 include:

- No watering between 10 a.m. and 6 p.m.
- No excessive amounts of water leaving a property and flowing down the gutter.
- No allowing sprinklers to "water" side-

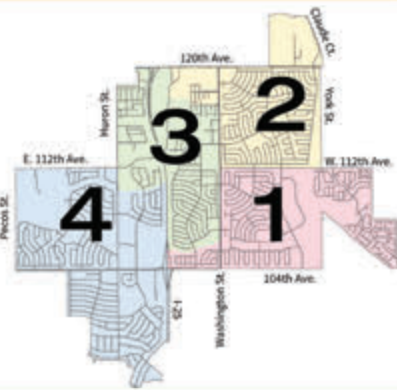

Teachers and staff are committed to helping young people become productive, healthy, ethical and successful citizens who are prepared for post-secondary education and/or the workforce.



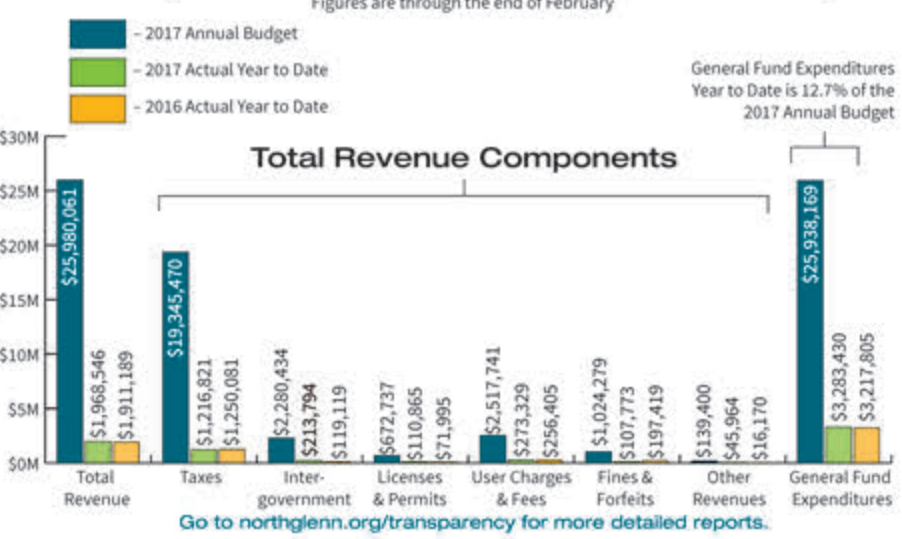

Remodel for Fire Station 63

North Metro Fire Rescue District began work in late April on a large remodel of Fire Station 63 on Irma Drive in Northglenn.

Station 63 is the district's busiest fire station and also one of its oldest and smallest stations. The remodel will enlarge the station to house three emergency response vehicles instead of two. The firefighters' living quarters will be built above the bay housing the fire engine and ambulance, turning the existing structure into a more modern and efficient two-story building. The construction, contracted through Mark Young Construction, is expected to be completed in October of this year.

During the remodel, crews will live on site in temporary housing and will still run emergency calls from the location to minimize any impact on response times.

WHERE ARE THE CITY HALL RECYCLE BINS?

In order to accommodate the Food Truck Carnival, the recycle bins in the parking lot at City Hall will move across the street to E.B. Rains Jr. Memorial Park from May 8 to 15. The bins are free, open to the public and single-stream, so you don't have to sort the materials.

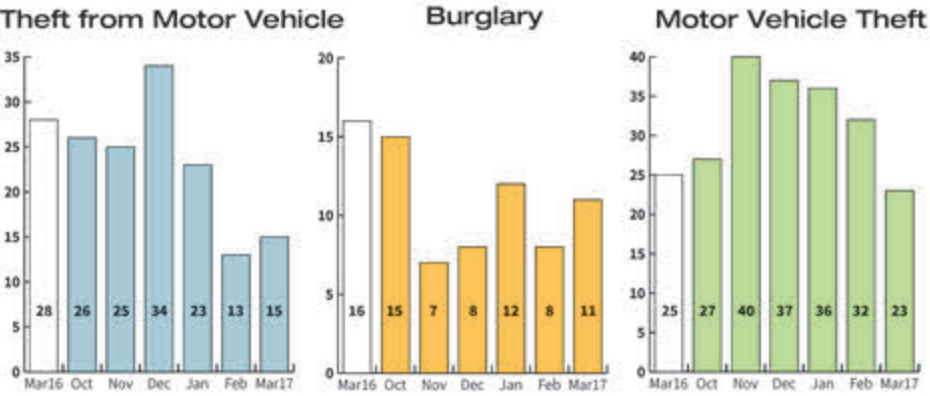

More than \$28 million has been reinvested by NURA over the last two decades to enhance commercial areas throughout the city. These funds have been used to make public and private development improvements for commercial-related redevelopment and revitalization projects throughout the city. NURA's primary purpose is to implement the City Council's redevelopment plan to improve areas in Northglenn by eliminating blight. Learn more by visiting northglenn.org/nura.

Highlights

• **Core Progression** received an **\$11,156** BIG grant to assist with the exterior improvements of their new location. They were located at 455 W. 115th Ave., Unit 4 for five years, but needed to expand. They purchased the 5,000 square-foot former bank building at 10693 Melody Drive and completed major renovations on the interior and exterior of the building. The 4,268-square-foot facility also serves as the office for **Hogan Health and Chiropractic, Phoenix Massage Therapy** and two other physical therapists. NURA provided a **\$419** grant to Hogan Health as well for signage.



• **IHOP** spent \$1.2 million to renovate their new 7,100-square-foot restaurant in the Northglenn Marketplace. NURA provided **\$322,500** in grants and incentives to assist with the renovations. This IHOP is the first in the state to have a coffee bar. It employs 120 people and is open 24/7.

• **Concentus Partners, LLC** received an incentive from NURA for **\$450,000** to assist with exterior improvements to the Wells Fargo Office Building, 10701 Melody Drive. Concentus bought that building, as well as 10699 Melody Drive (European Market) for \$4 million, and is investing \$1.325 million in improvements.

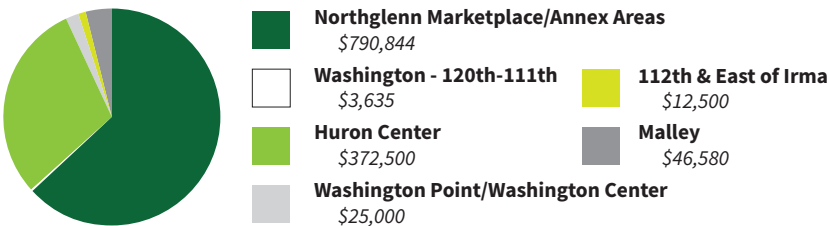


• NURA provided **\$12,500** to assist with exterior improvements to **Safeway**. It invested \$2 million to transition the store from an Albertsons as a result of their merger. The grocer, located in the Washington Point Shopping Center, features a Starbucks.

► Reduction of Water Use Encouraged

- walks, driveways or the street.
- No washing vehicles without a shut-off nozzle on the hose.
- No using water to wash impervious surfaces including: sidewalks, driveways, patios, gutters, sides of buildings, etc...
- Failure to repair outdoor plumbing leaks or leaks to sprinkler systems.

In addition, all residents are encouraged to use water wisely and practice conservation in their homes and yards. Voluntary measures that residents are encouraged to consider during the summer irrigation months include:

- Watering only two days per week.
- Watering during the coolest times of the day.
- Water each zone twice, with shorter cycles to get more water into the ground.
- Not watering when it is windy.
- Use a broom to sweep driveways and sidewalks.
- Check indoor and outdoor plumbing for leaks.

In an effort to improve customer service, the City Clerk's Office will start accepting passport applications by appointment only on May 1. This will reduce wait times and increase the efficiency of the application process.

You can set up an appointment by going to northglenn.org/passports. Appointments are available weekdays, 8:20 a.m.-4 p.m. The City Clerk's Office is located in City Hall, 11701 Community Center Drive.

New times, including some next day appointments, will be added on a continual basis, so check back often if you can't find a time that works.

You may set an appointment for a passport if any of the following are true:

- You are applying for your first U.S. passport
- You are under age 16
- Your previous U.S. passport was issued when you were under age 16
- Your previous U.S. passport was lost, stolen or damaged
- Your previous U.S. passport was issued more than 15 years ago

Appointments can be scheduled for an individual, couple or family.

Passports issued after the applicant was age 16 and less than 15 years ago must be renewed by mail using Form DS-82, which is available at northglenn.org/passports.

See a bee swarm? DO NOT ATTEMPT TO KILL THEM, please don't spray them with pesticides or water! Call the toll-free bee swarm hotline instead. There are volunteer beekeepers throughout the state ready to be dispatched to collect the bees and transfer them to a new home quickly and for free.

In Colorado, bees swarm from early April until the end of the summer with May and June being the busiest months. Swarms are generally quite passive but they can be alarming due to the numbers of bees within the swarm. Swarms will eventually leave on their own, or you can call a beekeeper to catch the bees as a swarm.

The honeybee population is shrinking, in 2015-16 beekeepers lost 44 percent of their colonies. We need bees! The bees that swarm are "survivor bees" and are crucial to our environmental health and in pollinating crops for our food supply.
