4. For customers who purchase a toilet after July 1, 2003

- Residential accounts** may schedule a free Special Pickup of your old toilet by calling 303.450.4004.
- Commercial accounts** must submit photo documentation of 1) the removal of the old toilet or 2) destruction of the old toilet. In addition, please call 303.450.8780 to schedule an installation inspection. Your rebate will be processed and a credit applied to your water account within 60 days.

5. **The applicant agrees to an on-site inspection** performed on non-holidays, Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m. You must own the living unit where the new toilet is located. The old toilet cannot be sold for reuse.

6. Rebates will be issued to the customer as a **CREDIT** to the utility billing account **within 60 days** from the approval date or as a **CHECK** to the customer. **Rebates will be \$75 per toilet for residential accounts and \$50 per toilet for commercial accounts.** Rebates are limited and available on a first come, first served basis.
