QUESTIONS:

- 1. What is the time frame of the job?
 - a) Work to be completed within 30 calendar days, start date expected mid-November and completion in mid-December.
- 2. Are we required to do traffic control? (Pertaining to tree 1, only one lane of traffic as is).
 - a) If a lane of traffic needs to be close, contractor to include the cost of traffic control in their bid. Contractor will need to submit a traffic control plan to the city for review.
- 3. All small growth/brush removed how far past the bridge? (Pertaining to tree 24, Vista prune)
 - a) From the diversion valve that goes into the lake to the grate where it begins to go underground.
- 4. Is Northglenn going to paint/mark trees for pruning/removal?
 - a) Northglenn will pain trees to be removed with a white mark, parks staff will be available for any other question or coordination issues.
- 5. Will the valve boxes/inlets to lake be in the work zone?

- a) Yes, they will be marked with blue paint.
- 6. Are pine trees 7 and 8 dead wooded all the way up?
 - a) Yes, anything 2inches or greater.
- 7. Do we need to close off the playground with signs, cones and caution tape?
 - a) Yes, for trees 9, 10, 11 the playground will need to be closed. The contractor needs to give city staff ample time to inform the community of the closure.
- 8. Trees 9,10 and 11 focus is on the playground side?
 - a) Entire trees need to be looked at with emphasis on branches extending over the playground.
- 9. Is there a public GIS we can access for the trees in question?
 - a) No.
- 10. Do you want the stump ground?
 - a) No, simply cut as low as possible.
- 11. Tree 22 and 23, remove branches over parking spot?
 - a) Yes, 2inch dead wood and anything below 13 feet.
- 12. Is the contract pieced out or is the whole contracted awarded to one company?
 - a) The contract will be awarded to a single contractor.
- 13. Do you want price per tree or the full amount for the bid?
 - a) Follow the bid summary, include a price per tree and a total for all items at the bottom.
- 14. Will the contractor receive help setting up no parks next to the row of locust trees or will that be the contractor responsibility?
 - a) The contractor will be responsible for setting up no parking zones next to the trees.
