Historic Walk

► Tunnel Mural Project Commemorates City's 50 Years Through Art

If you have not done so already, take time to walk through the pedestrian tunnel under Interstate 25 that links the Northglenn Civic Center to the RTD Wagon Road Park-N-Ride. You will not be disappointed. You may even feel inspired, nostalgic or just plain proud.

In celebration of the city's 50th Anniversary, Northglenn Arts partnered with the Northglenn Arts & Humanities Foundation (NAHF) to install the city's first public art mural. The project not only celebrates our milestone anniversary, but it helps beautify a heavily-used pedestrian thoroughfare.

In the fall of 2018, a volunteer public art committee comprised of Northglenn residents and NAHF members selected Denver-based muralist Chad Bolsinger to design and complete the installation out of more than 40 artist submissions from around the country. Bolsinger began working in May and will complete the work, in his signature bold site-appropriate style, before July 4.

"Obviously, we're celebrating 50 years," Bolsinger said. "So we want to draw attention to the past 50 years — what Northglenn is and how it came to be — while bringing attention to where Northglenn is going."

Come to the city's July 4th festivities to meet the artist and experience the finished piece!



CITY WARDS



APRIL 22, 2019

Ordinances – 2nd Reading:

Civic Center Rezone OK'd

CB-1925 – City Council unanimously approved on second reading the rezoning of the Civic Center Property to Mixed-Use Corridor. This is in preparation of the redevelopment of the existing 20.59-acre Civic Center property, generally located between Community Center Drive and Interstate 25, south of the Webster Lake Promenade. Any future development would be required to conform to the development standards within the Unified Development Ordinance and the Civic Center Master Plan.

Station Village Property Rezone Approved

CB-1926 – City Council unanimously approved on second reading the rezoning of the Station Village property to Mixed-Use Corridor. The rezoning is being done in preparation for the development of the 5.4-acre property located on the northwest corner of 112th Avenue and York Street, near the FasTracks N-Line station. Any future development would be required to conform to the development standards within the Unified Development Ordinance and the Northglenn 112th Station Area Master Plan. Resolutions:

City to Join Colorado Legal Service Pilot Program

CR-14 – City Council unanimously approved a letter of commitment in support of the city joining an existing IGA with other local communities to participate in the Colorado Legal Services (CLS) pilot program. It provides legal services for low-income individuals, including seniors. The city will contribute \$12,000 each year for two years.

New Paint for 120th Bridge

CR-19 – City Council unanimously approved an intergovernmental agreement with CDOT, RTD and the City of Westminster for the repainting and maintenance cost sharing of the 120th Avenue bridge over Interstate 25. The total project cost is \$460,606.80

Event Permit Fees Waived

CR-32 – Council unanimously approved waiving special event permit fees for the Northglenn Community Foundation, Northglenn Historic Preservation Foundation and the Rotary Club of Northglenn-Thornton for events in 2019.

Cooksey Reappointed to Historic Commission

CR-38 – Council unanimously approved the reappointment of Diane Cooksey to the Historic Preservation Commission. Her term runs April 26, 2019, to April 26, 2022. The commission protects, preserves and enhances the city's cultural, social, economic, political and architectural heritage.

New Roof for City Hall

CR-39 – City Council unanimously approved an agreement between the city and CRW, Inc. for the City Hall roof replacement project. The work will be completed by the end of July. The total project cost is \$237,788.

Examination for Aquifers

CR-40 – City Council unanimously approved the professional services agreement with HRS Water Consultants, Inc. The study is being conducted to investigate the viability of injecting, storing and recovering treated water, known as aquifer storage and recovery or 'ASR', into the Denver Basin Aquifers which lie under the city. The contract amount is \$119,550.

Update for ROW Standards

CR-41 – City Council unanimously approved a professional services agreement between the city and Ulteig for the public right of way standards and specifications update project. The project is contracted for \$118,513.

2019 Pay Plan Change OK'd

CR-42 – City Council unanimously approved amending the Pay Plan to include the addition of an intern in the Public Works Department. The position will have an hourly range of \$14.61 to \$19.51.

Support for Historic Designation of St. Stephen's

CR-43 – City Council unanimously authorized the mayor to sign a letter of support for the nomination of St. Stephen's Church to the National Register of Historic Places.

Xcel Program to Help City with Saving Energy

CR-44 – City Council unanimously approved the signing of an MOU for the city and Xcel Energy to begin the implementation phase of the Partners in Energy Program. The program provides tools and resources to develop a plan to reduce energy use and costs.

Ralston House Donation OK'd

CR-45 – City Council unanimously approved a donation of \$16,247 to Ralston House for use at their Northglenn facility. That amount is the city's remaining funds/cost savings after completion of the recently-opened building.

MAY 13, 2019

Ordinances – 1st Reading:

2019 Budget Amended

CB-1927 – City Council unanimously approved on first reading amending the 2019 Budget to allow for the carry-over of 2018 appropriations and additional revenues and expenditures.

Resolutions:

Cathcart Reappointed to Youth Commission

CR-46 – Council unanimously approved the reappointment of Ben Cathcart to the Northglenn Youth Commission. His term runs May 7, 2019, to May 7, 2020. The Northglenn Youth Commission encourages youth to participate in community issues and gives them a voice in government. Members make recommendations to City Council and staff about topics that impact youth in the community.

Sculpture Placement OK'd

CR-47 – City Council unanimously approved the placement of *Butterfly* on the west end of the Justice Center West park property and *Wings of Freedom* in front of the Northglenn Justice Center. The action allowed for the placement on publicly-owned land.

Wellness Grant Accepted

CR-48 – City Council unanimously approved accepting a grant award of \$700 from Tri-County Health Department. The funds will be used toward the Employee Benefits and Wellness Fair.

Audit of the 2018 Comprehensive Annual Financial Report Accepted

CR-49 – City Council unanimously approved the acceptance of the annual audit report completed by the city's auditor. The independent audit is conducted annually. Go to www.northglenn.org/cafr to see the document.






March 2019 General Fund Financial Report



► Trailer Available to Reserve

Few things build a sense of community like a block party. Neighbors bring dishes and talk about what's going on, while kids play safely nearby.

"When neighbors have a chance to get to know each other, they find out there's more commonality and more collective purpose in what they do," said Neighborhood Services Supervisor Tom Carlson

To encourage more of these gatherings in Northglenn, residents can now rent the Block Party Trailer for a weekend.

The trailer includes all of the essentials to host a block party:

- Street barricades
- 12 tables
- 32 folding chairs
- Four ice chests and three water coolers
- Four pop-up canopy tents
- Variety of lawn games

You'll be able to see if the trailer is available for the date you want and to make sure your street may be eligible.

If everything checks out, you can download and fill out the application, which requires signatures from 80 percent of your neighbors.

Once everything is approved, city staff will drop off the trailer on the Friday afternoon prior to your party, and then come pick it up on Monday.

► New Rebate Program Encourages Residents to Reduce Lawn Size

Northglenn residents use on average 120 gallons of water per person, per day – but most of that water isn't even used directly by the people – it goes to watering yards.

Water is scarce and every drop counts in the arid climate of the Front Range. To conserve water, the most effective and aesthetic step is to replace grass with low-to-no water use landscaping.

To help encourage residents to take that step, the city is offering \$1 rebates per square foot of grass that you replace, up to \$1,000.

"Not only will you get a rebate on your water bill, but your new, water-efficient yard will save you money for years to come," said Water Resources Analyst Sophie Porcelli.

Before you start ripping out your grass, please go to www.northglenn.org/rebates to read all the conditions and processes

to receive the rebate.

Some of the more important rules include:

- This rebate cannot be used for artificial turf.
- The newly-landscaped area must have plants, and those plants must be water-efficient.
- The rebates cannot be applied retroactively.

In addition to turf reduction, the city provides other water conservation rebates for toilets, washing machines, rain barrels and sprinkler accessories. Northglenn residents can also have Resource Central come out and evaluate the efficiency of their automatic sprinkler system for free.

As of May, the Northglenn Urban Renewal Authority (NURA) has issued eight business grants totaling \$45,272 in 2019. This leverages \$536,506 in private commercial property improvements. Since 2005, NURA has awarded 137 grants and incentives for a total of \$17.8 million.

Huron Project Honored

The recently-completed Huron Center Redevelopment was a big success – and now others are starting to notice.

The project received a 2019 honorable mention Governor's Excellence Award from Downtown Colorado Inc. (DCI)

The \$13.5 million redevelopment wrapped up in late December after nearly 18 months of construction. This project brought new shopping, services and 150 jobs to Northglenn.

This public/private partnership between the property owners and the Northglenn Urban Renewal Authority (NURA) transformed the shopping area, located at 104th Avenue and Huron Street. Another \$3+ million was invested in the 104,322-square-foot property for the new construction of the Arby's and the build-out of the AutoZone and Save-A-Lot

stores. The latter two businesses moved into a former Albertsons store that was closed for more than a decade.

"Northglenn's Huron Center is a great example of what urban renewal authorities can do to revitalize challenging retail areas by bringing stakeholders to the table to address fragmented property ownership, environmental issues, code compliance issues, ancient Covenant Control Regulations (CCRs), lack of property management and \$3.2 million of necessary infrastructure improvements," said the DCI judges. "Congratulations Northglenn URA."

County Awards Grants for Parks



On May 14, the Adams County Board of Commissioners (BOCC) awarded two grants totaling \$525,000 for two park projects in the city.

A \$375,000 grant will be used for improving the Sensory Playground at E.B. Rains Jr. Memorial Park. The poured-in-place safety surface will be replaced and worn play features will be switched out.

The Sensory Playground provides a play space for children of all abilities. Constructed in 2003, it is one of the first playgrounds of its type in Colorado. The bright and whimsical playground not only provides a space for all children, but for parents and grandparents of all abilities as well.

The playground aims to engage children with features that stimulate the senses through sound, touch, motion and sight. Staff intends to select equipment that will increase opportunities for play. Construction is anticipated to take place this fall.

A second grant, for \$150,000, will go towards the final design of Justice Center West Park. This 3.5-acre space is located just west of the Northglenn Justice Center, 50 W. Community Center Drive. The final design of the park will include nature-based play, drought tolerant shrubs and grasses, ADA accessible looped trails, educational opportunities and spectacular views of the Front Range.

“The fully designed park will provide shovel-ready plans of a very special and unique new space for children and adults of all ages,” said Project Manager Dana Kester.

In total, the BOCC awarded \$6.6 million for 20 projects across the county in this round of grants. Funding comes from the Open Space Sales Tax that Adams County voters approved in 1999.


