As we look back on 2021, the biggest event by far was the opening of the new Northglenn Recreation Center, Senior Center and Theatre. This \$54 million, 87,887-square-foot facility will allow for top-notch services, programs and experiences for residents and visitors from throughout the north metro area.

City Council Legislative Recap: Jan. 2022

Here is a recap of recent votes, a glance into the most discussed topics and a look ahead for City Council. Council votes on two types of items: An ordinance (CB) is an enforceable law or regulation that requires two majority votes by council to pass; a resolution (CR) is a decision, opinion, policy or directive and only requires one majority vote to pass.

CITY REMEMBERS ODELL BARRY

The City of Northglenn mourns the loss of former mayor Odell Barry, who passed away on Jan. 2, 2022.

Barry was a mentor to Northglenn youth, a business owner and a proud father and grandfather.

After his retirement from professional football, Barry took that love of the sport to the community. Through summer football camps, he had a profound effect on the countless youth he mentored. As a volunteer and as a council member, recreational opportunities for youth remained one of Barry's passions.

He was a Ward 2 council member for eight years before serving as the mayor of Northglenn from Jan. 3, 1980, to Jan. 6, 1982.

As the first African American mayor of Northglenn, Barry was a trailblazer. He will be remembered in part for his leadership in establishing a master plan for the city, building a city hall and community center, and supporting an \$80 million water project. Barry was also very involved in the region, serving on many committees.

He was later honored by the African American Legacy Project for his major accomplishments in the business, sports and political worlds.

In 2019, Barry was one of the first two honorees of the Resident Recognition Program, which was part of the city's 50th Anniversary celebration.

Barry's inspiration and guidance will benefit the community for generations to come.





Getting to Know Your Council Members: Ward 1

Nicholas Walker



Walker

Born and raised in Kansas and coming to Northglenn after living in multiple states, new Ward 1 council member Nicholas Walker and his girlfriend Katie McKinney have fully embraced Northglenn. "I am an absolute cheerleader for the city because of some of the top-notch services our small city offers," he said. Some of his favorites include the

Access Northglenn app, Gun Safe Rebate Program and Block Party Trailer.

Before being elected to council, he volunteered as a Snow Stormer, served on the Liquor License Authority, and was vice chair of the Community Co-Production Policing (CCPP) Board. Serving on the CCPP Board comes from an enthusiastic support of the Northglenn Police Department.

Walker wanted to run for office to bring a different perspective to council, which includes abandoning all COVID-19 mandates, including masks and vaccinations, and protecting the 2nd Amendment.

• What Community Issues Are You Most Interested in Addressing? Withdrawing from any mandates or guidance from the Tri-County Health Department (TCHD) immediately, including the mask mandate. While I support our decision to leave TCHD at a later date, we need to be vigilant and make sure former TCHD employees are not brought into the Adams County solution.

I would also like to see real progress on our homelessness issues. These need to be decided by residents and elected officials.

• What Regional Issues Are You Most Interested in Addressing? It is time we improve our road infrastructure. While the N-Line is a great addition, it lacks any real-world viability for most of our residents. The only project CDOT should be working on is doubling the size of Interstate 25 from E-470 to C-470. I also support strict lane restrictions for commercial vehicles since our law enforcement community does not enforce the left lane laws currently. This will bring real economic aid and revenue to the region.

• So Far, What Achievement, Action or Work Are You Most Proud of During Your Tenure on Council? I am proud to have been involved in creating the Community Co-Policing Advisory Board and Diversity, Inclusivity and Social Equity Board. These boards have been entrusted to handle very important tasks to better our community, and I look forward to seeing all they are able to

accomplish. I am also proud that council unanimously approved the temporary cold weather shelter at our old recreation center to serve people experiencing homelessness in Northglenn.

• What Is the Most Important Thing You Have Learned During Your Time on Council? During my time on council, I have learned the importance of being flexible and open-minded when making decisions that will impact our community. It's important to listen to all viewpoints and educate myself before making important decisions.

• What Do You Feel Are The Biggest Issues That Northglenn Faces Right Now? I think the biggest issues facing Northglenn right now are pedestrian safety and roadway safety. This is what I hear most from residents and I agree. I look forward to making progress on these issues over my next two years on council.

• What Is the Most Rewarding Part of Being on Council? The most rewarding part of being on council for me has been the relationships with other council members and our residents. I've been able to meet many new people and learn their stories during my time on council. I also find it very rewarding to work with passionate council members who have ambitious goals to better Northglenn.



General Fund Expenditures Year to Date is 89.1% of the 2021 Annual Budget


Total Revenue Components

Northglenn is a city that welcomes involvement and input. Yet, there are times when input is delivered in an intimidating, threatening or condescending way. Sometimes commenters resort to name-calling and misinformation. In these instances, I encourage you to put that behavior in perspective and listen. We all get to choose how we show up. Do your homework, get involved, ask questions, stand up for what you think is best for your community and talk to your elected officials. This is the essence of representative democracy. It is through your participation and voices that we have built a Northglenn we are proud of and collectively we'll continue to move the city forward.

At Northglenn High School, students are provided a diverse and outstanding educational experience, particularly through Northglenn's STEM education program.

The Northglenn High School STEM program now offers the Pathways in Technology Early College model, where students

will leave high school with a diploma, Associate in Applied Science degree and relevant work experience with local business partners. In addition to the opportunities within the school, students also have access to Career and Technical Education via the district's FutureForward program.

Students in the STEM program

Chief Talk: A Quarterly Message from Police Chief Jim May

Team Up to Stop Motor Vehicle Thefts

Northglenn is joining forces with the Colorado Metropolitan Auto Theft Task Force (CMATT) to combat the ever-increasing motor vehicle thefts in the Denver Metro area.

It is common for motor vehicle offenders to steal cars to commit other serious and dangerous crimes like robbery or burglary. Offenders are also stripping down the stolen vehicle and selling parts for a profit through what is known as “chop shops”.

The partnership with CMATT is a multi-agency collaborative effort providing tools and techniques, that are not otherwise available, to address motor vehicle theft across jurisdictions. A network of law enforcement agencies, investigators, and prosecutors are working to build solid cases and hold thieves accountable for their crimes. The National Insurance Crime Bureau and the Colorado Auto Theft Prevention Authority are also partnering to make this possible by provid-

ing resources and funding. By combining efforts and resources we are multiplying forces to protect people, their property, and insurance companies.

CMATT reports the Chevrolet Silverado, Hyundai Sonata, Kia Optima, Kia Sportage, and Ford F-250 made the top five most stolen vehicles in the Denver Metro area in the third quarter of 2021. Northglenn has seen the same patterns of vehicles stolen and a 55% total increase in motor vehicle thefts in our jurisdiction from 2020 to 2021.

Vaccine and Booster Recommendations

- The CDC recommends that everyone ages 5 and up receive COVID-19 vaccinations.
- Boosters are recommended for fully-vaccinated people ages 12 and up. The time between receiving your second dose and the booster depends on which vaccine you took; for details go to <https://tchd.org/covidvaccine>.

Find a Vaccine Clinic

- Anyone 12 and older can get a free COVID-19 vaccine at a pharmacy, doctor's office, pop-up or local clinic, or mobile vaccine bus near you. Teens ages 12 to 17 should only receive the Pfizer vaccine. No ID or insurance is needed. Most providers take walk-ins and same-day appointments. You are entitled to paid time off from your job to get vaccinated and recover from side effects.
- Vaccines for youth ages 5 to 11 are also available, but appointments are likely necessary. Check with your child's medical provider or go to <https://covid19.colorado.gov/kids-vaccines> for clinics available.
- You can find a vaccine clinic by

The Community Co-Production Policing (CCPP) Advisory Board launched to work with the Northglenn Police Department (NPD) and City Council based on the belief that the community should be integrally involved in shaping the policing strategies that affect it.

The NPD Traffic Unit doubled from two to four officers.

On June 14, Gov. Jared Polis signed HB21-2165 at Northglenn's own The Glenn Bar and Grill. The bill offered state sales tax relief over the summer to food-related industries hard hit by the pandemic.

The \$26 million Force Main A and Lift Station A replacement project extended the life of the city's wastewater network through upgraded infrastructure.

The lift station is scheduled go be fully replaced by this spring, while the force main work is nearly complete. Go to Page 9 for more information.

Blighted property on 112th Avenue and Washington Street was purchased by NURA for future redevelopment.

Building permit applications was made available online.

The city joined the Adams County Built for Zero team, which works to build systems and processes so when a person does experience homelessness it is a brief, one-time occurrence.

A street outreach team was formed based on a Homelessness Task Force recommendation.

The Minor Home Repair Program re-launched in partnership with Adams County.

Priority Area #6: Diverse Community

A Black History Month movie series was hosted by the Diversity, Inclusivity, and Social Equity Board, with proceeds going to Cleo Parker Robinson Dance.

The Northglenn Veterans Memorial was re-dedicated after its new plaza was completed as part of Phase 1 of the CCMP.



The celebratory sculpture "Illumination" hangs in the lobby of the Parsons Theatre. The \$187,000 price tag was covered thanks to the NAHF, SCFD and generous donations.

Based on a true story of Chicano workers protesting conditions, "War of the Flowers" by Su Teatro helped celebrate the new Parsons Theatre's opening.

The Deza Estates neighborhood was surveyed to determine its historic significance.

Priority Area #7: Sustainability

The Sustainability Committee was launched to advise council on all matters related to sustainability, especially the environment.

The Electric Vehicle Readiness Plan is being crafted through the Partners in Energy with Xcel Energy to electrify the city's municipal fleet, provide infrastructure in Northglenn, and increase public adoption.

Stage 1 Drought conditions were declared in May, leading to a 10% water use reduction by the city and voluntary reductions by residents.

Two air quality monitoring stations were installed in September in cooperation with TCHD, one at the new rec center and the other at Northwest Open Space.

200,000: Estimated gallons of water saved annually by residents who utilized Resource Central's free Slow the Flow sprinkler inspection program



A quick roundup of roadwork activities in your city.

120th Avenue Expansion

The city plans to widen 120th Avenue to three lanes in both directions between Washington Street and York Street,

plus install 8- to 10-foot pedestrian trails on both sides of the road.

The project is tentatively set to begin in late spring/early summer.
