WEATHER OR NOT, HERE IT COMES ...

The structure of the new Northglenn City Hall has been completed, just in time to deal with Colorado's late winter/early spring wet weather.

Roofing and temporary plastic sheathing were installed to prevent damage from the elements to the structural frame. The construction team has been working on both interior and exterior framing.

As the exterior framing is completed, the team has begun exterior sheathing, which is the yellow material that can be seen on the outside of the building. Sheathing functions as a protective layer to keep heat in the building and wind and water out. Staff anticipates the installation of window framing in February.

When it opens, this 32,600-square-foot

facility will be Net Zero and have a CORE Green Building Rating – the first municipal building in Colorado to achieve that certification. The \$33.8M building is being funded completely through reserves and will be located next to the current City Hall.

DEMOLITION OF OLD REC CENTER SET FOR FEBRUARY

Demolition for the old recreation center is scheduled to begin in February, provided the city receives the necessary state permits. The demolition should be

completed within 45 days of commencement of work. Once completed, the city will begin the reevaluation for what is next with City Council and the community.



► Deza Estates Neighborhood Added to National Register of Historic Places

On Nov. 24, 2023, the Deza Estates neighborhood was added to the National Register of Historic Places, the official list of the nation's locations worthy of preservation.

The district is an example of the Modern Movement style of architecture and unique post-war development. The neighborhood consists of entirely custom-built homes at a time when suburban residential developments were based on a set number of models to choose from. The homes were built in the late 1950s, before Northglenn incorporated, and sit in the southwest corner of the city.

Deza Estates joins the Stonehocker Farmhouse and St. Stephen's Lutheran Church as city locations on the register.

This provided environmentally-friendly noxious weed and fire mitigation to the land that is normally done with either lawnmowers or chemicals. The goats covered twice as much area as originally planned, and the city will bring them back in 2024. As a bonus, nearly 1,500 people came out for a live goat encounter on April 30.

On Oct. 18, the city welcomed the **U.S. Environmental Protection Agency (EPA)** and other local officials during a media event highlighting community-led air quality monitoring projects in Adams and Jefferson counties, funded in part by the EPA. About the District Attorney's Office

The 17th Judicial District Attorney's Office is responsible for the prosecution of misdemeanor, traffic, and felony cases in Adams and Broomfield Counties. It represents the people of the State of Colorado and seeks justice on behalf of crime victims and their families.



The city's Aquifer Storage and Recovery *(ASR)* project has hit its first milestone. The desired depth of the first well has been reached and now construction of that well will begin shortly. Once construction of the first well is finalized, staff can begin test pumping. After the first well is finished, crews will start on the second. Both will be located adjacent to the Water Treatment Facility, 2350 W. 112th Ave.

ASR injects water into deep bedrock aquifers for long-term storage. The water is then available for future recovery during droughts or seasonal high-demand periods. If successful, ASR will provide additional drought resilience and sustainability to the city's water supplies. The viability of the project will be decided sometime in 2024.

Drilling can run 24 hours a day at times. Sound walls are in place to help mitigate the noise, but those nearby may still be able to hear the drilling.


