



Liquor License Modification of Premises

Once an establishment is granted a liquor license, the licensee may not materially or substantially alter the licensed premises without prior written approval from both the local and state licensing authorities. To "alter" means: any increase or decrease in the capacity of the establishment; moving, adding or increasing the size of a bar; the sealing off, creation of, or relocation of doors or passages. In short, a licensee may not change or modify the premises in such a way that would affect the basic character or physical structure as it was previously approved, unless pre-approval is obtained.

The following must be submitted to the City Clerk's Office if a modification of premises is desired:

- ✓ DR8442 Permit Application and Report of Changes.
- ✓ Plans and Specifications on 8 ½" x 11" paper with the premises outlined in bold
 - The existing layout "before" of the licensed premises; and
 - The proposed layout "after" modification
- ✓ Copy of the current lease in the licensee's name which demonstrates legal possession of the modified premises or any other document allowing the use of the property proposed for inclusion in the licensed premises
- ✓ Fees:
 - o \$150.00 payable to the Colorado Department of Revenue.

Process: Approval by the Northglenn Liquor Licensing Authority and State of Colorado Liquor Enforcement Division must take place prior to the commencement of construction. The City Clerk's Office will forward the application to the State Authority on behalf of the applicant. The applicant will be notified of the final approval in writing.

Note: City and State approval of the Permit Application and Report of Changes pertaining to the liquor licenses in no way exempts the applicant from securing the proper building permits or from conforming to all applicable building codes and laws.
